SUBJECT: Mutual Aid Patrol/Station Coverage for Springdale Police Department

The following assignments are effective as indicated to provide mutual aid police service to the City of Springdale, Ohio at the request of Springdale Police Chief Thomas S. Wells.

Effective Sunday night March 22, 2020 at 2300 hours clerk Kelley Hopewell will staff the clerical/station function of the Springdale Police station, working 2300-0700 hours through Friday morning March 27, 2020 at 0700 hours. Third shift clerical coverage for the weekend March 27, 2020 through March 29, 2020 has yet to be determined.

Effective Monday morning March 23, 2020 at 0700 hours, the following sworn officers are assigned to provide patrol coverage to the City of Springdale, Ohio. This coverage is necessary to augment the Springdale Police Department's patrol division, which is currently unable to fully staff this function as the department grieves the loss of Officer Kaia Grant in a tragic line-of-duty death which occurred March 21, 2020 and also makes preparations for her funeral. This coverage is scheduled through March 31, 2020 at 0700 hours.

Colerain Police Officers will staff three of Springdale's four patrol beats (with one sergeant or OIC and two patrol officers) 24 hours per day through 0700 hours Tuesday March 31, 2020 while Sharonville Police Department staffs the remaining beat. Springdale Police Department will also have at least one officer on the road and one supervisor on station each day. Lieutenant Phillips (Colerain) and Lieutenant Preuss (Sharonville) will also assist on the road throughout the week.

The following Colerain Police Officers have been assigned to assist Springdale Police with patrol duties and will work 12 hour shifts and beats as indicated in the attached addendum:
