

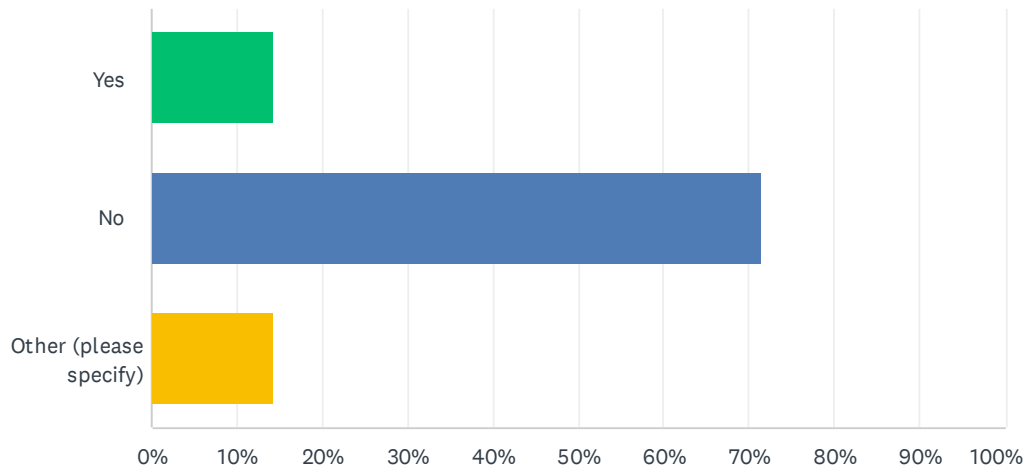

- (a) No person shall recklessly interfere with pedestrian or vehicular traffic in a public place.
- (b) "Interfere with pedestrian or vehicular traffic" as used in this section means to do any of the following:
